

HUNTER NATION 2019 HUNTING TRIP SWEEPSTAKES

Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR TO WIN A PRIZE; A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

1. ELIGIBILITY: The Hunter Nation 2019 Hunting Trip Sweepstakes (“**Sweepstakes**”) is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are twenty-one (21) years of age or older at the time of entry (“**Eligible Entrant**”). Void in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Employees, officers and directors (including immediate family members (spouse, domestic partner, child, sibling, parent and their respective spouses/domestic partners, regardless of where they reside) and members of the same household, whether or not related) of Hunter Nation (“**Sponsor**”) and each of its respective parents, affiliated companies, subsidiaries, licensees, divisions, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes (collectively, the “**Sweepstakes Entities**”) are not eligible to participate or win any of the Prizes as defined below. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. All entries for a Drawing must be received by Sponsor by the applicable Drawing date specified above in order to be eligible to win. 4. WINNER SELECTION:

Approximate Retail Value (“ARV”) of the entire Prize is \$4,999.

Winner is responsible for all transportation to and from the Prize location. Winner must meet all requirements for participation in the hunt, including: timely executing and returning all documents and releases necessary to be awarded the Prize; eligibility under federal, state and local law for ownership (if applicable), use and possession of a firearm; and eligibility under state law to obtain a Kansas hunting license. Winner’s guest must be at least twenty-one (21) years of age at

the time of winner notification. Approximate Retail Value (“ARV”) of the entire Prize is \$1,000.

Winner must meet all requirements for participation in the hunt, including: timely executing and returning all documents and releases necessary to be awarded the Prize; eligibility under federal, state and local law for ownership (if applicable), use and possession of a firearm; and eligibility under Canadian (British Columbia) law to obtain a British Columbia hunting license. Winner’s guest must be at least twenty-one (21) years of age at the time of winner notification. Approximate Retail Value (“ARV”) of the entire Prize is \$4,999.
